This is a summary of the annual report of the Barron Collier Partnership, LLLP, EIN 650247894, Plan BARRON COLLIER COMPANIES GROUP INSURANCE BENEFIT PROGRAM, Plan No. 501, a welfare benefit plan, for period January 01, 2025 through December 31, 2025. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Barron Collier Partnership, LLLP has committed itself to pay certain Health, Dental, Vision and Temporary Disability claims incurred under the terms of the plan.

The plan has contract with PRINCIPAL LIFE INSURANCE COMPANY to pay Life Insurance, Long-term Disability incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2025 were \$85,200.00.
